Dear Mayor Bass:

The Alliance for Community Transit - Los Angeles (ACT-LA) is a Los Angeles County coalition of 42 community-focused organizations that strives to create just, equitable, and sustainable transportation systems and neighborhoods. We place the interests of working-class communities and communities of color first as we work towards a more sustainable region. For more than a decade, our membership has worked with LA Metro's Board of Directors and staff to center the needs of frequent transit users in the agency's decision making.

As the newly elected mayor of the City of Los Angeles, you have a momentous opportunity to uplift and advance transit equity in our region through your appointments to the LA Metro Board of Directors. The perspectives and concerns of low-income riders of color, who make up a

majority of Metro's transit ridership—62% of Metro riders earn less than \$20,000 a year¹—are currently underrepresented on the board. You can fix this inequity through the three Metro board members you will soon appoint. ACT-LA recommends the following candidates join you in representing the people of the City of Los Angeles on the LA Metro Board of Directors:

- 1. Elected official: Eunisses Hernandez, City of Los Angeles Council Member, District 1, and former nonprofit executive director
- Public member: Tamika Butler, Esq., former California Transportation Commissioner, former nonprofit executive director, former private sector Director of Planning and Director of Equity & Inclusion, and current UCLA urban planning doctoral student
- Public member: Mike Bonin, former City of Los Angeles Council Member and former Metro board member

These candidates would serve as excellent representatives of Metro's diverse ridership. They have demonstrated a deep commitment to public service with an emphasis on prioritizing the needs of vulnerable and underserved communities.
