Bus Lane Selection & Community Engagement

Bus Lane Selection

- Collected comment cards at Transit Justice Summit in 2020
- Developed selection <u>criteria</u> through ACT-LA Transit Justice Committee
- Analyzed data measuring criteria, ranking top candidates for a bus lane
- Convened Transit Justice Committee and community members to vote on a bus lane, informed by analysis



Community Engagement

- Involvement of community in bus lane selection process
- 20 interviews with bus riders to understand what good bus service means to them
- Multiple Transit Justice Committee and Subcommittee meetings with ACT-LA members to workshop and vote on bus lane demands
- Business outreach and collection of <u>300 signatures</u> from community members in support of Vermont bus lane

Petition translation: "I would like to receive all forms and information translated into Korean from the Los Angeles Housing Authority and all government agencies. It is the right of city residents to receive information translated into English, and with the correct information, they can use the housing department and city government services. We also demand the installation of dedicated bus lanes on Vermont Ave. Working people and seniors need high-quality, frequent, and free bus service."





Waiting Environment

ACT-LA Proposal

- Wait time displays and public water at all major intersections
- Clear signage, wayfinding, bus rider bill of rights, and trash bins at every stop
- Tree planting and non-hostile shelters at every bus stop without shade
- Electrification of buses along the corridor
- Preserve street vending and expand sidewalk along Salvadoran vending corridor
